On July 10, 2018, the Wisconsin Board of Nursing ("Board") issued an Order Granting Limited License ("Order"), granting Applicant a limited professional nursing license with certain terms and conditions.

On October 13, 2022, the Board considered Respondent's request for termination of direct supervision and/or reduction in the frequency of drug and alcohol screens. Based upon the information of record, the Board finds and makes the following:

ORDER

- 1. Respondent's request for termination of direct supervision is hereby GRANTED.
- 2. Respondent's request for a reduction in the frequency of drug and alcohol screens is hereby GRANTED. Respondent's frequency of drug and alcohol screens is reduced to not less than twenty-eight (28) times per year and one (1) annual hair test.
- 3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
 - 4. This order is effective the date of its signing.
