On July 10, 2018, the Wisconsin Board of Nursing (“Board”) issued an Order Granting Limited License (“Order”), granting Applicant a limited professional nursing license with certain terms and conditions.

On October 13, 2022, the Board considered Respondent’s request for termination of direct supervision and/or reduction in the frequency of drug and alcohol screens. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent’s request for termination of direct supervision is hereby GRANTED.
2. Respondent’s request for a reduction in the frequency of drug and alcohol screens is hereby GRANTED. Respondent’s frequency of drug and alcohol screens is reduced to not less than twenty-eight (28) times per year and one (1) annual hair test.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
