On November 5, 2019, the Wisconsin Board of Nursing ("Board") issued an Order Granting Limited License ("Order") limiting Applicant's registered nurse license with certain terms and conditions.

On August 11, 2022, the Board considered Applicant's request for a reduction in drug testing frequency and/or the removal of the limitations and the return of his license to full, unrestricted status. Based upon the information of record, the Board finds and makes the following:

ORDER

- 1. Applicant's request for a reduction in drug and alcohol screens is hereby GRANTED. Applicant's frequency is reduced to not less than thirty-six (36) screens per year.
- 2. Applicant's request for the return of her registered nurse license (license no. 171588-30) to full, unrestricted status is hereby DENIED.
- 3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
 - 4. This order is effective the date of its signing.
