On November 15, 2019, the Wisconsin Real Estate Appraisers Board issued a Final Decision and Order ("Order") requiring Respondent to complete fifty (50) hours of corrective education in various topics prior to accepting or completing hotel valuation appraisals. On January 10, 2022, Respondent's Certified General Appraiser certificate of licensure and certification was suspended for failure to complete the education as ordered.
