On December 16, 2019, the Wisconsin Board of Nursing (“Board”) granted Applicant a limited practical nurse license in the state of Wisconsin. Pursuant to the Order Granting Limited License (“Order”) issued on the same date, Applicant may petition the Board for the return of full licensure upon the completion of at least one year of successful compliance with all terms and conditions of the Order.

On April 14, 2022, the Board considered Applicant’s request for removal of the limitations and the return of her license to full, unrestricted status. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Applicant’s request for the return of her practical nurse license (license no. 304071-31) to full, unrestricted status is hereby GRANTED.
2. All limitations and encumbrances upon Applicant’s credential are hereby removed.
3. This order is effective the date of its signing.
