On January 6, 2020, the Wisconsin Board of Nursing ("Board") issued an Order Granting Limited License ("Order"), granting Applicant a professional nursing license (#251474-30) with certain terms and conditions.

On March 10, 2022, the Board considered Applicant's request for a reduction in the frequency of drug and alcohol screens and AA/NA meetings. Based upon the information of record, the following is entered:

ORDER

- 1. Applicant's request for a reduction in the frequency of drug and alcohol screens and AA/NA meetings are GRANTED. Applicant's frequency in screens is reduced to not less than twenty-eight (28) screens per year plus one (1) annual hair test. Applicant's AA/NA meetings are reduced to one (1) per month.
- 2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
 - 3. This order is effective the date of its signing.
