## TO: CHARLES M BOWER II RN EAST TROY WI 53120

On February 13, 2020, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license for an indefinite period. Respondent has been granted a stay of suspension and his license is currently limited with certain terms and conditions.

On June 9, 2022, the Board considered Respondent's request for reduction in drug test frequency to 24 annually, termination of AA/NA meetings, termination of drug and alcohol treatment, removal of alcohol consumption limitation, and/or access to controlled substances. Based upon the information of record, the Board finds and makes the following:

### <u>ORDER</u>

1. Respondent's request for a reduction in drug and alcohol screens is hereby GRANTED. Respondent's frequency is reduced to not less than 36 urine screens per year and one annual hair test.

2. Respondent's request for termination of AA/NA meetings and termination of drug and alcohol treatment is hereby GRANTED.

3. Respondent's request for removal of alcohol consumption limitation and access to controlled substances is hereby DENIED.

4. All other terms and conditions of the Order not otherwise modified remain in full force and effect.

5. This order is effective the date of its signing.
