On April 9, 2020, the Wisconsin Board of Nursing issued a Final Decision and Order (“Order”) limiting Respondent’s registered nursing license with certain terms and conditions. On August 13, 2021, Respondent’s license was suspended for violation of the Order when she failed to pay the costs of the proceeding, complete the education requirements, and failed to enroll and participate in an approved drug monitoring program.

On December 7, 2022, the Board Liaison considered Respondent’s request for termination of the suspension. Based upon the information of record, the Board finds and makes the following:

ORDER

1. The suspension of Respondent’s registered nursing license (license number 130971-30) is hereby terminated.
2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
3. This order is effective the date of its signing.
