On May 1, 2020, the Wisconsin Real Estate Examining Board (“Board”) issued an Order granting a limited license (“Order”) limiting Applicant’s real estate salespersons license with certain terms and conditions. Applicant may petition the Board for removal of the limitations upon demonstrating continuous, successful compliance with the terms and conditions of the Order for at least two (2) years.

On June 16, 2022, the Board considered Applicant’s request for a full, unrestricted real estate salesperson license. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Applicant’s request for the return of his real estate salespersons license (license number 725595-94) to full, unrestricted status is hereby GRANTED.
2. All limitations and encumbrances upon Applicant’s credential are hereby removed.
3. This order is effective the date of its signing.
