On September 15, 2020, the Wisconsin Social Worker Section of the Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete six (6) hours of education in boundaries and dual relationships within 90 days and nineteen (19) hours of continuing education, including four (4) hours on ethics and boundaries, within 180 days. On August 17, 2021, Respondent's certificate to practice social work was suspended for failure to complete the education as ordered.

Based upon the information of record, which includes proof that Respondent has now completed the education, the following is entered:

ORDER

1. The suspension is terminated and Respondent's certificate to practice social work (certificate number 6182-120) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
