On November 4, 2020, the Wisconsin Dentistry Examining Board ("Board") issued a Final Decision and Order ("Order"), suspending Respondents license to practice dentistry for an indefinite period. Respondent has been granted a stay of suspension and his license is currently limited with certain terms and conditions.

On November 25, 2022, the Board designee considered Respondent's request for a reduction in the frequency of drug and alcohol screens. Based upon the information of record, the Board designee finds and makes the following:

ORDER

- Respondent's request for a reduction in drug and alcohol screens is hereby 1. GRANTED. Respondent's frequency is reduced to not less than thirty-six (36) per year.
- All other terms and conditions of the Order not otherwise modified remain in full 2. force and effect.
