On January 27, 2021, the Wisconsin Social Worker Section of the Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete ten (10) hours of education in "boundaries and professional ethics" within six (6) months.
