On January 27, 2021, the Wisconsin Social Worker Section of the Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete ten (10) hours of education in "boundaries and professional ethics" within six (6) months. On December 27, 2021, Respondent's credential to practice clinical social work was suspended for failure to complete the education as ordered.

Based upon the information of record, which includes proof that Respondent has now completed the education, the following is entered:

ORDER

1. The suspension is terminated and Respondent's credential to practice clinical social work (credential number 7050-123) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
