On January 28, 2021, the Wisconsin Pharmacy Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's license to practice pharmacy with certain terms and conditions.

On December 1, 2022, the Board considered Respondent's request for removal of the limitations and grant her license to full, unrestricted status. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for her license to practice pharmacy (license number 10709-40) to be full and unrestricted is hereby GRANTED.
