On January 26, 2021, the Wisconsin Professional Counselor Section of the Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board issued an Order Granting Limited License ("Order"), which granted Applicant a limited professional counselor training license with certain terms and conditions. - 2. Respondent may petition for termination of suspension upon demonstrating continuous, successful compliance with the terms and conditions of the Order for at least the most recent ninety (90) days.
- 3. This order is effective the date of its signing.
