On April 16, 2021, the Wisconsin Department of Safety and Professional Services issued a Final Decision and Order ("Order") limiting Respondent's certificate to practice as a clinical substance abuse counselor with certain terms and conditions. Pursuant to the Order, Respondent's license may be suspended, without hearing, for substantial or repeated violation of any provision.

Information has been received that demonstrates Respondent is in violation of the terms of the Order and as a result, the following is entered:

1. Respondent's certificate to practice as a clinical substance abuse counselor (certificate number 15332-132) is hereby SUSPENDED until further notice.
