On May 5, 2021, the Wisconsin Dentistry Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's license to practice dentistry. Respondent was required to complete twelve (12) hours of education on the topic of proper prescribing of opioids, six (6) hours of education on the topic of pain management, and six (6) hours of education on the topic of proper diagnosis, treatment planning, and patient communication pursuant to the terms of the Order.
