On May 5, 2021, the Wisconsin Dentistry Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's dental hygienist license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.
