On June 16, 2021, the Wisconsin Board of Nursing issued an Order Granting Limited License ("Order"), which granted Applicant a limited professional nursing license with certain terms and conditions.

On November 10, 2022, the Board considered Applicant's requests to terminate direct supervision, reduce the frequency of drug/alcohol screens to 36 times per year, and reduce AA meetings to once per week. Based upon the information of record, the following is entered:

ORDER

1. Applicant's request to terminate direct supervision requirement is hereby GRANTED.

2. Applicant's requests for a reduction in the frequency of drug/alcohol screens and AA meetings to once per week are hereby DENIED.

3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
