On July 13, 2021, the Wisconsin Board of Nursing issued an Order Granting Limited License ("Order"), which granted Applicant a limited registered nurse license with certain terms and conditions. Pursuant to the Order, Applicant's license may be suspended, without further notice or hearing, for substantial or repeated violation of any provision.

Information has been received that demonstrates Applicant is in violation of the terms of the Order and as a result, the following is entered:

ORDER

1. Applicant's registered nurse license (#261688-30) is hereby SUSPENDED until further notice.
2. Respondent may petition for termination of suspension upon demonstrating continuous, successful compliance with the terms and conditions of the Order for at least the most recent sixty (60) days.
3. This order is effective the date of its signing.
