On July 21, 2021, the Wisconsin Medical Examining Board ("Board") issued an Order Final Decision and Order ("Order") suspending Respondent's certificate to practice as a respiratory care practitioner for an indefinite period. Respondent has been granted a stay of suspension and her certificate is currently limited with certain terms and conditions.

On October 19, 2022, the Board considered Respondent's request to terminate the direct supervision requirement and to decrease frequency of drug and alcohol screens. Based upon the information of record, the Board finds and makes the following:

ORDER

- 1. Respondent's request to terminate the direct supervision requirement is hereby GRANTED.
- 2. Respondent's request for a decrease in frequency of drug and alcohol screens is hereby GRANTED. Respondent's s frequency is reduced to not less than thirty-six (36) times per year.
- 3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
 - 4. This order is effective the date of its signing.
