On October 14, 2021, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") limiting Respondent's professional nursing license with certain terms and conditions.

On September 8, 2022, the Board considered Respondent's request for a reduction in drug testing frequency and/or the removal of the limitations and the return of her license to full, unrestricted status. Based upon the information of record, the Board finds and makes the following:
