On August 25, 2021, the Wisconsin Department of Safety and Professional Services ("Department") issued a Final Decision and Order ("Order") suspending Respondent's certificate to practice substance abuse counseling for 30 days. Respondent was required to comply with all terms and conditions of the Final Decision and Order that was issued in DLSC Complaint number 19 CPC 023 and to pay \$443.00 in costs of the proceeding within 120 days.

Respondent has submitted proof that she successfully complied with all terms and conditions of the Final Decision and Order that was issued in DLSC Complaint number 19 CPC 023 and, as a result, the following is entered:

ORDER

1. Respondent's certificate to practice as a substance abuse counselor (certificate 18435-130) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
