On October 6, 2021, the Architect section of the Wisconsin Examining Board of Architects, Landscape Architects, Professional Engineers, Designers and Professional Land Surveyors issued a Final Decision and Order ("Order") requiring Respondent to complete 1.25 hours of continuing education within ninety (90) days and pay \$531.00 in costs of the proceeding within ninety (90) days.
