On November 11, 2021, the Wisconsin Nursing Home Administrators Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete four (4) hours of education on "ethics and/or resident rights" and eight (8) hours on "protecting residents from sexual harassment and/or sexual abuse" within six (6) months and pay \$733.00 in costs of the proceeding within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. Respondent's Nursing Home Administrator license (#3378-65) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
