On November 16, 2021, the Wisconsin Occupational Therapists Affiliated Credentialing Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's license to practice as an occupational therapist. Respondent was required to complete eight (8) hours of education in professional ethics pursuant to the terms of the Order.
