On December 9, 2021, the Wisconsin Board of Nursing issued a Final Decision and Order ("Order") requiring Respondent to complete three (3) hours of education on "documentation for the correctional nurse," three (3) hours of education on "mental health nursing in a correctional setting," and one (1) hour on the topic of "chronic illness in the correctional setting within thirty (30) days and pay \$7,500.00 in costs per a prearranged payment plan.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

# <u>ORDER</u>

1. The suspension is terminated and Respondent's professional nursing license (#95069-30) and Advanced Practice Nurse Prescriber license (#1856-33) are hereby returned to full, unrestricted status.

- 2. All limitations and encumbrances upon Respondent's credential are removed.
- 3. This order is effective the date of its signing.
