On December 9, 2021, the Wisconsin Board of Nursing issued a Final Decision and Order (“Order”) requiring Respondent to complete three (3) hours of education on “recognizing and assessing an acute change in patient condition” within ninety (90) days and pay \$552.00 in costs of the proceeding within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has completed the education and submitted the payment for costs in full, the following is entered:

1. Respondent’s professional nursing license (#257010-30) and practical nursing license (#323049-31) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent’s credentials are removed.
3. This order is effective the date of its signing.
