On January 11, 2022, the Wisconsin Social Worker Section of the Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board issued an Order Granting Limited License ("Order"), which granted Applicant a limited Licensed Clinical Social Worker credential with certain terms and conditions. Pursuant to the Order, Applicant's license may be suspended, without further notice or hearing, for substantial or repeated violation of any provision.

Information has been received that demonstrates Applicant is in violation of the terms of the Order. As a result, the following is entered:

ORDER

1. Applicant's Licensed Clinical Social Worker credential (credential number 6720-123) is hereby SUSPENDED until further notice.
2. Applicant may petition for termination of suspension upon demonstration of complete, successful compliance with the terms of the Order for a continuous sixty (60) days from the date of this Order.
3. This order is effective the date of its signing.
