
On February 3, 2022, the Wisconsin Real Estate Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent Nelson's real estate broker's license. Respondent Nelson was required to complete an education course on the topic of forms pursuant to the terms of the Order.
