The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board of Nursing (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

#### FINDINGS OF FACT

1. Respondent Antonio Garcia Merino, R.N., (Year of Birth 1965) is licensed in the state of Wisconsin as a registered nurse, having license number 237517-30, first issued on August 18, 2017, and current through February 28, 2022. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is in Minneapolis, Minnesota 55409.

2. At all times relevant to this proceeding, Respondent was employed as a registered nurse at a medical center in Yuma, Arizona (Facility). Respondent was practicing in Arizona pursuant to his Colorado multistate license (number 1653503).

3. On July 6, 2021, the Colorado Board of Nursing (CO Board) issued an Order admonishing Respondent and ordering him to complete the following continuing education: 12 hours on the topic of assessment, 12 hours on the topic of medication administration, and 12 hours on the topic of documentation (CO Order).

4. The CO Order established that, while working at the Facility, Respondent fell below generally accepted nursing standards as follows:

- He failed to ensure that an IV was properly started.
- He made incorrect entries in patient charts.
- He failed to make essential entries in patient charts, including what interventions he did.
- He failed to either complete assessments or, if they were completed, he failed to document the assessments.

5. On or about November 1, 2021, Respondent submitted evidence to the CO Board that he successfully complied with the CO Order. Respondent's Colorado nursing license is now expired with no restrictions for reinstatement.

6. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

# CONCLUSIONS OF LAW

1. The Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 441.07 and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

2. By the conduct described in the Findings of Fact, Respondent violated Wis. Admin. Code N 7.03(1)(b) by having a license to practice nursing or a nurse licensure compact privilege to practice denied, revoked, suspended, limited, or having the credential holder otherwise disciplined in another state, territory, or country.

3. As a result of the above violation, Respondent is subject to discipline pursuant to Wis. Stat. 441.07(1g)(b) and (d).

## <u>ORDER</u>

1. The attached Stipulation is accepted.

2. Respondent is REPRIMANDED.

3. The Board recognizes and accepts the successful completion of the continuing education in the CO Order as the equivalent of the education it would have otherwise ordered. The 36 hours of continuing education completed by Respondent may not be used to satisfy any other continuing education requirements that have been or may be instituted by the Board or Department.

4. Within 90 days from the date of this Order, Respondent shall pay COSTS of this matter in the amount of \$223.00.

5. Payment of costs (made payable to Department of Safety and Professional Services), and other information required by this Order, shall be submitted to:

6. In the event Respondent violates any term of this Order, his license to practice as a registered nurse in the state of Wisconsin (license number 237517-30), or his right to renew his license, may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of the Order. The Board may, in addition and/or in the alternative refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.

7. This Order is effective on the date of its signing.

## IN THE MATTER OF DISCIPLINARY : PROCEEDINGS AGAINST : ANTONIO GARCIA MERINO, R.N., RESPONDENT. : STIPULATION ORDER 0007828

# Division of Legal Services and Compliance Case No. 21 NUR 427

Respondent Antonio Garcia Merino, R.N., and the Division of Legal Services and Compliance, Department of Safety and Professional Services, stipulate as follows:

1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.

2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:

- the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
- the right to confront and cross-examine the witnesses against Respondent;
- the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
- the right to testify on Respondent's own behalf;
- the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
- the right to petition for rehearing; and
- all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.

3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.

4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Board of Nursing (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.

5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.

6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.

7. Respondent is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.

8. The Division of Legal Services and Compliance joins Respondent in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.
