The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board of Nursing (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

1. Respondent Kathy A. Galvez, R.N., A.P.N.P., (Year of Birth 1962) is licensed in the state of Wisconsin as a registered nurse, having license number 97480-30, first issued on September 4, 1987, and current through February 28, 2022. Respondent is also certified as an advanced practice nurse prescriber, having certificate number 3020-33, first issued on November 28, 2006, and current through September 30, 2022. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is in St. Peters, Missouri 63376.

2. Respondent is also credentialed in the state of Missouri as a registered nurse and nurse practitioner.

3. On September 24, 2018, the Missouri Board of Nursing (Missouri Board) issued an Order which placed Respondent on probation for three years and required that she contract with a third-party administrator (TPA) for daily check-ins and random drug and alcohol screenings (Missouri Order).

4. The Missouri Order was based on Respondent's 2014 citation for operating while intoxicated (1st offense) and subsequent diagnosis of Alcohol Use Disorder.

5. Respondent violated the Missouri Order when she failed to check in with the TPA on five days and checked in outside of the required window on four days.

6. On September 7, 2021, the Missouri Board revoked the Missouri Order and placed Respondent on probation for one additional year and required, among other things, continued daily check-ins and random drug and alcohol screenings.

7. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 441.07 and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

2. By the conduct described in the Findings of Fact, Respondent has a license to practice nursing or a nurse licensure compact privilege to practice denied, revoked, suspended, limited, or otherwise disciplined in another state, territory, or country within the meaning of Wis. Admin. Code § N 7.03(1)(b).

3. As a result of the above conduct, Respondent is subject to discipline pursuant to Wis. Stat. § 441.07(1g)(b) and (d), and Wis. Admin. Code § N 7.03.

ORDER

1. The attached Stipulation is accepted.

2. Respondent's license to practice as a registered nurse (license no. 97480-30) and her certificate to practice as an advanced practice nurse prescriber (certificate no. 3020-33) are LIMITED as follows:

- a. Respondent is to maintain full and complete compliance with all terms, limitations, and conditions imposed against her nursing credentials by the Missouri Board.
- b. Respondent shall provide the Board with a copy of any document issued by the Missouri Board which alters the conditions of Respondent's continued practice of nursing in the state of Missouri, including any document advising reinstatement of full licensure, within 15 days of issuance of document.

- c. In the event Respondent intends to practice nursing in Wisconsin during the pendency of this Order, Respondent shall provide the Board with notice in writing at least 30 days prior to the commencement of practice in Wisconsin. That notice shall include identity of the employer, work location(s) including addresses and phone numbers, and the type of practice. The Board may require additional limitations be imposed on Respondent's Wisconsin credentials based on any limitations or conditions imposed by the Missouri Board, Respondent's compliance therewith, and anticipated scope of practice in Wisconsin.
 - d. A determination by the Missouri Board that Respondent has violated any term, limitation, and/or condition imposed on her Missouri nursing licenses is a violation of this Order.
 - e. Upon Respondent providing proof sufficient to the Board, or its designee, that she has successfully complied with all terms and conditions imposed by the Missouri Board, and that her Missouri credentials have been restored to full, unrestricted status, the Board or its designee shall remove the limitation(s) imposed by this Order on Respondent's practice of nursing in Wisconsin.
3. Within 90 days from the date of this Order, Respondent shall pay COSTS of this matter in the amount of \$445.00.
4. Any requests, petitions, payments of costs (made payable to Department of Safety and Professional Services), and other information required by this Order shall be submitted to:

5. In the event Respondent violates any term of this Order, Respondent's credentials (license no. 97480-30 and certificate no. 3020-33), or Respondent's right to renew her credentials, may, in the discretion of the Board or its designee, be **SUSPENDED**, without further notice or hearing, until Respondent has complied with the terms of the Order. The Board may, in addition and/or in the alternative refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.

6. This Order is effective on the date of its signing.

STIPULATION

ORDER 0007829

Division of Legal Services and Compliance Case No. 21 NUR 542

Respondent Kathy A. Galvez, R.N., A.P.N.P., and the Division of Legal Services and Compliance, Department of Safety and Professional Services, stipulate as follows:

1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.

2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:

- the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
- the right to confront and cross-examine the witnesses against Respondent;
- the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
- the right to testify on Respondent's own behalf;
- the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
- the right to petition for rehearing; and
- all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.

3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.

4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Board of Nursing (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.

5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division

of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.

6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.

7. Respondent is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.

8. The Division of Legal Services and Compliance joins Respondent in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.
