On February 15, 2022, the Wisconsin Social Worker Section of the Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board issued a Final Decision and Order ("Order") limiting Respondent's certificate to practice social work with certain terms and conditions. Pursuant to the Order, Respondent's license may be suspended, without hearing, for substantial or repeated violation of any provision.

Information has been received that demonstrates Respondent has failed to enroll and participate in an approved drug monitoring program and is therefore is in violation of the terms of the Order. As a result, the following is entered:

1. Respondent's certificate to practice social work (certificate number 6709-120) is hereby SUSPENDED until further notice.
