On February 15, 2022, the Wisconsin Funeral Directors Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent Tetzlaff's funeral director's license. Respondent Tetzlaff was required to complete the course, "Cremation Arrangement Conference Best Practices" offered by the Cremation Association of North America, pursuant to the terms of the Order.
