On February 16, 2022, the Wisconsin Medical Examining Board (“Board”) issued a Final Decision and Order (“Order”) limiting Respondent’s license and registration to practice medicine and surgery. Respondent was required to complete the *Medical Ethics, Boundaries, and Professionalism* course offered by Case Western Reserve University School of Medicine pursuant to the terms of the Order.

Respondent has submitted proof that he successfully completed the required education and as a result the following is entered:
