The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Psychology Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

1. Licensee Sandra L. Eugster, Ph.D., (Year of Birth 1960) is licensed in the state of Wisconsin as a psychologist, having license number 2043-57, first issued on September 9, 1997 and current through September 30, 2023. Licensee's most recent address on file with the Wisconsin Department of and Professional Services (Department) is in Madison, Wisconsin 53711.

Prior Disciplinary Proceedings

2. On August 24, 2018, the Department opened DLSC Case No. 18 PSY 013 after receiving a complaint that Licensee allegedly spoke to a client's (Client A) ex-husband's attorney

about an assessment she conducted on the client's current relationship without their permission. The case was closed without discipline due to a pending civil suit between the parties.

#### Current Case

3. After the civil suit related to 18 PSY 013 resolved, the Department opened the current case. The terms of the settlement of the civil suit remain confidential.

4. On June 26, 2017, Client A and her husband signed an informed consent form stating that the materials of their treatment would be held confidential unless otherwise indicated in writing.

5. On April 10, 2018, Licensee disclosed information to Client A's ex-husband's attorney regarding co-parenting counseling, family dynamics/situations, and other related matters.

6. On July 24, 2018, Licensee's attorney responded that, since the co-parenting mediation for Client A was court-ordered, no HIPAA violations were made by Licensee's release of information to the counsel of a party to the mediation. Licensee's attorney also stated that Licensee did not perform any professional evaluation or assessment of Client A or her husband, so Licensee did not possess any private health information to disclose.

7. The Department's investigation revealed that, on April 17, 2018, Licensee billed Client A and her ex-husband's insurance for an integrated biopsychosocial assessment, including history, mental status, and recommendations. Licensee collected a co-payment for the assessment, which she admitted she did not complete.

8. In resolution of this matter, Licensee consents to the entry of the following Conclusions of Law and Order.

#### CONCLUSIONS OF LAW

1. The Wisconsin Psychology Examining Board is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

#### ORDER

1. The attached Stipulation is accepted.

2. Within six (6) months of the date of this Order, Licensee shall, at her own expense, take and successfully complete four (4) hours of education in forensic practice (which includes ethics) and two (2) hours of education on billing practices as follows:

- a. Each course attended in satisfaction of this Order must be pre-approved by the Board or its designee. Licensee shall be responsible for locating course(s) satisfactory to the Board and for obtaining the required approval of the course(s) from the Board or its designee. Licensee must take and pass any exam offered for the course(s).


- b. Licensee shall submit proof of successful completion of the education in the form of verification from the institution providing the education to the Department Monitor at the address stated below. None of the education completed pursuant to this requirement may be used to satisfy any continuing education requirements that have been or may be instituted by the Board or Department and may not be used in any future attempt to upgrade a credential.
  - c. The Board's monitoring liaison may change the number of credit hours and/or education topics in response to a request from Licensee. The monitoring liaison may consider the topic availability and/or hours of education when determining if a change to the ordered education should occur.

Sandra L. Eugster, Ph.D. (Licensee) and the Division of Legal Services and Compliance, Department of Safety and Professional Services stipulate as follows:

1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Licensee consents to the resolution of this investigation by Stipulation.

2. Licensee understands that by signing this Stipulation, Licensee voluntarily and knowingly waives the following rights:

- the right to a hearing on the allegations against Licensee, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
- the right to confront and cross-examine the witnesses against Licensee;
- the right to call witnesses on Licensee's behalf and to compel their attendance by subpoena;
- the right to testify on Licensee's own behalf;
- the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
- the right to petition for rehearing; and
- all other applicable rights afforded to Licensee under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.

3. Licensee is aware of Licensee's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.

4. Licensee agrees to the adoption of the attached Final Decision and Order for Remedial Education by the Wisconsin Psychology Examining Board (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order for Remedial Education without further notice, pleading, appearance or consent of the parties. Licensee waives all rights to any appeal of the Board's order, if adopted in the form as attached.

5. If the terms of this Stipulation are not acceptable to the Board the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division

of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.

6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Licensee, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order for Remedial Education.

7. Licensee is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order for Remedial Education is a public record and will be published in accordance with standard Department procedure.

8. The Division of Legal Services and Compliance joins Licensee in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order for Remedial Education.
