
On February 24, 2022, the Wisconsin Professional Engineer Section of the Wisconsin Examining Board of Architects, Landscape Architects, Professional Engineers, Designers, and Professional Land Surveyors issued a Final Decision and Order ("Order") suspending Respondent's Professional Engineer certificate of registration and requiring Respondent to complete two (2) hours of PDHs in "professional conduct and ethics."

Based upon the information of record, which includes proof that Respondent has now completed the education, the following is entered:

ORDER

1. The suspension of Respondent's Professional Engineer certificate of registration (no. 29512-6) is terminated.
2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
3. This order is effective the date of its signing.
