On March 2, 2022, the Wisconsin Dentistry Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's license to practice dentistry. Respondent was required to complete two (2) hours of education on patient documentation and two (2) hours of education on the topic of diagnostics pursuant to the terms of the Order.

Respondent has submitted proof that he successfully completed the required education and as a result the following is entered:
