On April 14, 2022, the Wisconsin Board of Nursing issued a Final Decision and Order ("Order") requiring Respondent to pay \$778.00 in costs of the proceeding and complete five (5) hours of education on the topic of "fall response and/or fall assessment in elderly adults", both within ninety (90) days from the date of the Order.
