On April 20, 2022, the Wisconsin Medical Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete the "Medical Ethics, Boundaries, and Professionalism" course offered by Case Western Reserve University School of Medicine for a total of 15.75 AMA PRA Category 1 Credits within six (6) months and pay \$1,193.00 in costs of the proceeding within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. Respondent's license to practice medicine and surgery (license no. 39684-20) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
