On May 4, 2022, the Wisconsin Dentistry Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's license to practice dentistry. Respondent was required to complete eight (8) hours of education on the topic of management of medically-compromised patients including those on blood thinners and those with diabetes, and two (2) credits on the topic of documentation and medical-history taking pursuant to the terms of the Order.

Respondent has submitted proof that he successfully completed the required education and as a result the following is entered:

ORDER

1. Respondent's license to practice dentistry (license number 1001540-15) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
