### PROCEDURAL HISTORY

This matter comes before the Wisconsin Cosmetology Examining Board (Board) as six citations to which Respondents have made no timely response. Based on the record in this case, the Board adopts as its Final Decision in this matter the following Findings of Fact, Conclusions of Law, and Order.

### FINDINGS OF FACT

1. Respondent Nguyet Nguyen (Birth Year 1965) is licensed in the state of Wisconsin as a cosmetologist, having credential number 92276-82, first issued on March 1, 2011 and current through March 31, 2023. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is in Pewaukee, Wisconsin 53072. 2. Respondent Nailistic of Wisconsin LLC is licensed in the state of Wisconsin as a cosmetology establishment, having credential number 45559-80, first issued on December 26, 2018 and current through March 31, 2023. Respondent's most recent address on file with the Department is in Milwaukee, Wisconsin 53217.

3. Respondent Nguyet Nguyen is identified in Department records as the responsible licensee for Nailistic of Wisconsin LLC.

4. On December 9, 2019, the Department received a complaint alleging that only three of Respondents' employees were licensed and that one employee had bad body odor and did not wash her hands between eating and providing services. The Division of Legal Services and Compliance (DLSC) subsequently opened Case Number 19 BAC 095 for investigation.

5. Following an inspection on September 14, 2021, a Division of Legal Services and Compliance (Division) investigator issued six citations to Respondents for violating Wis. Stat. § 454.06(7) and Wis. Admin. Code §§ Cos 3.01(6), Cos 4.01(1), Cos 4.02(4), Cos 4.10(1), and Cos 4.10(2).<sup>1</sup> Service was accomplished by mail. True and correct copies of these citations are attached as Exhibit A and are incorporated herein by reference.

6. Respondents have not paid the citations, which were issued to Respondents on March 18, 2022.

### CONCLUSIONS OF LAW

1. The Wisconsin Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15.

2. Respondents violated Wis. Stat. § 454.06(7) by failing to post practitioner licenses in a conspicuous place in the licensed establishment.

3. Respondents violated Wis. Admin. Code § Cos 3.01(6) by failing to store cleaning and disinfecting equipment in an secured location.

4. Respondents violated Wis. Admin. Code § Cos 4.01(1) by maintaining equipment and tools for providing waxing services in an unsanitary and unsafe condition.

5. Respondents violated Wis. Admin. Code § Cos 4.02(4) by failing to store waxing strips and cotton in a covered container.

6. Respondents violated Wis. Admin. Code § Cos 4.10(1) by failing to disinfect reusable manicure instruments.

7. Respondents violated Wis. Admin. Code § Cos 4.10(2) by failing to keep disinfectant used for decontamination in a covered container.

8. As a result, Respondents are subject to discipline pursuant to Wis. Stat. §§ 454.15(2)(i) and (3).

9. Respondents are in default pursuant to Wis. Admin. Code § Cos 10.07(1) for failing to make a deposit or otherwise respond to the citations in a timely fashion.

10. Pursuant to Wis. Admin. Code Cos 10.07(1), the Board has the authority to issue an order of default against Respondents for the amount identified in the citations without further proceedings.

### <u>ORDER</u>

1. Respondents are in DEFAULT and shall pay to the Wisconsin Department of Safety and Professional Services a total forfeiture in the amount of \$900 within thirty (30) days from the date of this Order.
