On June 15, 2022, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's certificate to practice as a respiratory care practitioner (certificate number 3018-28). Respondent's suspension was stayed, and her certificate was limited with certain terms and conditions.

Information has been received that demonstrates Respondent is in violation of the terms of the Order and, as a result, the following is entered:

ORDER

1. The stay of suspension is removed and Respondent's certificate to practice as a respiratory care practitioner (certificate number 3018-28) is hereby SUSPENDED until further notice.
2. Respondent may petition the Board or its designee for termination of the suspension upon demonstrating continuous compliance with the terms and conditions of the Order for at least the most recent thirty (30) days.
3. This order is effective immediately.
