On October 11, 2022, the Wisconsin Medical Examining Board ("Board") removed Respondent's stay of suspension for violation of the Final Decision and Order ("Order") dated June 15, 2022. Respondent has submitted a petition for reinstatement of the stay and proof of continuous compliance with the terms of the Order. Based upon the information of record, which demonstrates that Respondent qualifies for a stay at this time, the following is entered:

ORDER

1. The suspension of Respondent's certificate to practice as a respiratory care practitioner (certificate number 3018-28) is hereby STAYED.
2. The stay is continuous, contingent upon Respondent's compliance with the terms and conditions of the Order.
3. This order is effective immediately.
