On June 15, 2022, the Wisconsin Medical Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete four (4) hours of education on the topic of "proper prescribing of amphetamines" and four (4) hours of education on the topic of "proper medical documentation" within 90 days and pay \$1,423.00 in costs of the proceeding within 90 days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. Respondent's license to practice medicine and surgery (license no. 23110-20) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
