The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Department of Safety and Professional Services (Department). The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

1. Respondent Sylvia M. Hill, (Year of Birth 1991) is not and has never been licensed as a registered nurse in the state of Wisconsin.

2. On November 12, 2020, Respondent applied for a temporary special permit to practice as a registered nurse in Wisconsin via Emergency Order 16 (Application #740769). As of the date of this order, the application remains pending, and the Department has not granted a permit to Respondent.

3. On June 9, 2021 Respondent applied for a Wisconsin registered nurse license via endorsement (Application #768332). On August 2, 2021, the Department requested further information regarding the application, but Respondent never provided a response. As of the date of this order, the application remains pending, and the Department has not granted a license to Respondent.

4. From November 16, 2020, to August 3, 2021, Respondent was assigned to a hospital in Wausau, Wisconsin, by a staffing agency. During this time, Respondent held herself out and worked as a registered nurse without a valid license to practice as a registered nurse in Wisconsin.

5. During this time, Respondent held single state licenses to practice as a registered nurse in Indiana and Kentucky. Respondent incorrectly believed the Kentucky license she held was a multistate license and that a special permit to practice in Wisconsin had been granted to her.

6. Respondent currently holds a single-state license to practice as a registered nurse in Indiana (license number 28206362A), first issued on November 15, 2012, and current through October 31, 2023.

7. Respondent consents to the entry of the following conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Department has jurisdiction in this matter pursuant to Wis. Admin. Code ch. SPS 3 and Wis. Stat. § 440.21, and is authorized to enter into the attached Stipulation and Order pursuant to Wis. Stat. § 227.44(5) and Wis. Stat. § 441.13(3).

2. Pursuant to Wis. Stat. § 441.06(4), no person may practice or attempt to practice professional nursing, hold herself out as a registered nurse, use the title or letters "Registered Nurse" or "R.N.", or otherwise seek to indicate that she is a registered nurse, unless she is licensed under Wis. Stat. § 441.06.

3. By the conduct described above, Respondent violated Wis. Stat. § 441.06(4) by practicing and holding herself out as a registered nurse in Wisconsin without a license.

<u>ORDER</u>

1. The attached stipulation is accepted.

2. Unless and until Respondent is properly licensed as a registered nurse by the Wisconsin Board of Nursing, Respondent is enjoined and prohibited from practicing professional nursing, holding herself out as a registered nurse, using the title "Registered Nurse" or suffix "R.N.", or otherwise seeking to indicate that she is a registered nurse in the state of Wisconsin. Violation of this special order may result in a forfeiture of up to \$10,000 for each day of violation. See Wis. Stat. § 440.21(4)(a).

3. If the Department determines that there is probable cause to believe that Respondent has violated any terms of this Administrative Injunction, the Department may refer the violations covered by this decision and order to any appropriate prosecutorial unit for review for possible criminal charges.

Respondent Sylvia M. Hill and the Division of Legal Services and Compliance (Division), Department of Safety and Professional Services (Department), stipulate as follows:

1. This Stipulation is entered into as a result of a pending investigation by the Division. Respondent consents to the resolution of this investigation by Stipulation.

2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:

- the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
- the right to confront and cross-examine the witnesses against Respondent;
- the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
- the right to testify on Respondent's own behalf;
- the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
- the right to petition for rehearing; and
- all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.

3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.

4. Respondent agrees to the adoption of the attached Administrative Injunction by the Department. The parties to the Stipulation consent to the entry of the attached Administrative Injunction without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Department's Administrative Injunction, if adopted in the form as attached.

5. If the terms of this Stipulation are not acceptable to the Department, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division for further proceedings. In the event that the Stipulation is not accepted by the Department, the parties agree not to contend that the Department has been prejudiced or biased in any manner by the consideration of this attempted resolution.

6. The parties to this Stipulation agree that the attorney for the Department may appear before the Department for the purposes of speaking in support of this agreement and answering questions that the Department may have in connection with deliberations on this Stipulation.

7. Respondent is informed that should the Department adopt this Stipulation; the Department's Administrative Injunction is a public record and will be published in accordance with standard Department procedure.

8. Respondent is further informed that should the Department adopt this Stipulation, the Department's Administrative Injunction will be reported as required by the National Practitioner Databank (NPDB) Guidebook and as otherwise required by any licensure compact or any other state or federal law.

9. The Division joins Respondent in recommending the Department adopt this Stipulation and issue the attached Administrative Injunction.
