On July 20, 2022, the Wisconsin Medical Examining Board issued a Final Decision and Order ("Order") requiring Respondent to pay \$691.00 in costs of the proceeding and complete three (3) hours of education on "patient record keeping", both within ninety (90) days from the date of the Order.

The information of record demonstrates that Respondent has failed to pay the costs of the proceeding and to complete the education requirements. Therefore, the following is entered:

### ORDER

Respondent's license to practice medicine and surgery in the state of Wisconsin 1. (License No. 35687-20) is hereby SUSPENDED.

The suspension shall remain in effect until Respondent has paid the costs of the 2. proceeding in full and has demonstrated successful completion of the education requirements of the Order.
