On August 11, 2022, the Wisconsin Board of Nursing issued a Final Decision and Order ("Order") limiting Respondent's license to practice as a registered nurse. Respondent was required to complete four (2) hours of education on the topic of "delegation," two (2) hours of education on the topic of "coordination of care," and two (2) hours of education on the topic of "proper assessments" within ninety (90) days pursuant to the terms of the Order and to pay \$566.00 in costs of the proceeding within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

### ORDER

1. Respondent's license to practice as a registered nurse (license number 123481-30) is returned to full, unrestricted status.

2. All limitations and encumbrances upon Respondent's credential are removed.

3. This order is effective the date of its signing.
