The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Massage Therapy and Bodywork Therapy Affiliated Credentialing Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

- 1. Respondent Fang Wang, L.M.T., (Year of Birth 1971) is licensed in the state of Wisconsin to practice massage therapy and bodywork therapy, having license number 15253-146, first issued on April 24, 2020, and current through February 28, 2023. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is in New Berlin, Wisconsin 53151.
- 2. At all times relevant to this matter, Respondent was the sole owner and operator of a spa located in New Berlin, Wisconsin (Spa).

- 3. The Department received a complaint alleging that a massage therapist engaged in sexual behavior during a massage at the Spa on March 18, 2021. This matter was opened to investigate the allegations.
- 4. On November 8, 2021, a Department investigator performed an on-site inspection of the Spa with the New Berlin Police Department and interviewed Respondent.
 - 5. Respondent denied engaging in any sexual behavior with a client.
- 6. Respondent was unable to produce any client records during the Department's inspection. Respondent stated she does not maintain records, nor does she have clients sign an informed consent form prior to each appointment.
- 7. Respondent's massage therapy and bodywork therapy license was not displayed or visible at the Spa during the Department's inspection on November 8, 2021.
- 8. On November 22, 2021, the New Berlin Police Department informed the Department that they had insufficient evidence to charge Respondent with prostitution-related crimes but would continue to monitor the establishment.
- 9. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 460.14 and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. Based on the Findings of Fact, Respondent engaged in unprofessional conduct by failing to maintain accurate and timely records necessary for the continuity of a client's massage therapy or bodywork therapy treatment, pursuant to Wis. Admin. Code § MTBT 5.02(8).
- 3. Based on the Findings of Fact, Respondent engaged in unprofessional conduct by failing to document informed consent, pursuant to Wis. Admin. Code § MTBT 5.02(9)(a).
- 4. Based on the Findings of Fact, Respondent engaged in unprofessional conduct by failing to display her license in her place of business or practice so that it can easily be seen and read by the public, pursuant to Wis. Admin. Code § MTBT 5.02(28).
- 5. As a result of the above conduct, Respondent is subject to discipline pursuant to Wis. Stat. § 460.14(2)(g) and (j) and Wis. Admin. Code Ch. MTBT 5.

ORDER

- 1. The attached Stipulation is accepted.
- 2. This Final Decision and Order (Order) is effective on the date of its signing.
- 3. Respondent's license to practice massage therapy and bodywork therapy in the state of Wisconsin (license no. 15253-146) is SUSPENDED for an indefinite period.
- 4. Respondent may petition the Board for a stay of the suspension by providing proof, which is determined by the Board or its designee to be sufficient, that Respondent has fulfilled the following requirements:
 - a. Respondent shall at her own expense successfully complete six (6) hours of education on the topic of recordkeeping, and six (6) hours of education on the topic of informed consent, offered by a provider pre-approved by the Board monitoring liaison, including taking and passing any exam offered for the courses.
 - b. Respondent shall submit proof of successful completion of the education in the form of verification from the institution providing the education to the Department Monitor at the address stated below. None of the education completed pursuant to this requirement may be used to satisfy any continuing education requirements that have been or may be instituted by the Board or Department, and also may not be used in future attempts to upgrade a credential in Wisconsin.
 - c. The Board monitoring liaison may change the number of credit hours and/or education topics in response to a request from Respondent. The monitoring liaison may consider the topic availability and/or hours of education when determining if a change to the ordered education should occur.
- 5. Within ninety (90) days from the date of this Order, Respondent shall pay COSTS of this matter in the amount of \$1,337.00.
- 6. Any requests, petitions, payments of costs (made payable to Department of Safety and Professional Services), and other information required by this Order shall be submitted to:

In the event Respondent violates any term of this Order, Respondent's license (number 15253-146), or Respondent's right to renew her license, may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of the Order. The Board may, in addition and/or in the alternative refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.
