On September 7, 2022, the Wisconsin Dentistry Examining Board issued a Final Decision and Order ("Order") limiting Respondent's license to practice dentistry. Respondent was required to come into compliance with the continuing education requirements concerning the 2019-2021 biennium and the cardiopulmonary resuscitation requirements, within six (6) months. Respondent was required to complete two (2) hours of education on the topic of "patient record keeping" and two (2) hours of education on the topic of "risk management" within six (6) months and to pay \$553.00 in costs of the proceeding within 90 days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. Respondent's license to practice dentistry (license no. 5000432-15) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
